Dear RCSA 4th Grade Parents/Guardians,

This year at RCSA Innovations will be the 4th year for the **AAA Safety Patrol Program**. This is a nationally certified program implemented in hundreds of elementary schools across the nation. AAA's Safety Patrol Program is designed to provide students with the opportunity to learn about safety awareness and protocols, to take responsibility for the safety of their fellow students, and to provide leadership opportunities all while making the daily logistics run as smoothly and safely as possible.

This program is **optional** for all of our 5th graders and they will be selected by the teachers and patrol adviser. Safety patrols are a huge part of our school and are expected to be punctual when reporting for post and setting a good example for other students in the school. This is a privilege that can be taken away for slipping grades, behavior, or parents feel their student needs to focus on other things such as academics. Students will be placed in jobs according to their transportation methods & schedules. We will do our very best to accommodate everyone.

HOWEVER, for us to provide the maximum safety for all elementary students during arrival and dismissal, we will be selecting 15 patrols for morning and 15 patrols for afternoon shifts. The students will have to complete specific requirements to be a patrol in the 5th grade. They must complete the following requirements by *March 26th* . If selected your student will be asked to stay for a meeting about training on May 8,2018 from 3:00-3:45.

Mandatory requirements for applying to be a patrol:

- Discuss with parents and sign and return contract
- At least 1 or more-page paper explaining why you want to be a patrol. **This MUST be included**
- Teachers recommend student



 Maintain good behavior and grades (no "F", referrals, and conduct points based on situation)

Expectations for AAA Safety Patrol participants:

- 1. Maintain good grades (demonstrating consistent effort)
- 2. Exhibit exemplary behavior they are the leaders and role models
- 3. Demonstrate outstanding citizenship throughout the day both during duty and in the classroom.
 - a. Being respectful to all parties. Rude behavior is not tolerated and will end up in moving to a less important position
- 4. Be on time for duty understanding the importance of their role in providing safe and efficient movement of our students.
- 5. Must wear their belts and badges at all times.
- 6. Be responsible for all AAA materials they are in charge of or issued.

Specific information regarding procedures, protocols, absences and troubleshooting will be further discussed at the parent meeting. If you are not able to attend that meeting, the information will be sent home after the training.

Please find attached the parent/guardian permission form. This MUST be read, signed and returned by March 26, 2018 in order for RCSA to confirm that the program will be ready the first few weeks of school with our new patrols.

There is also a Washington D.C. trip at the end of the school year for all patrols and parents that want to attend.
